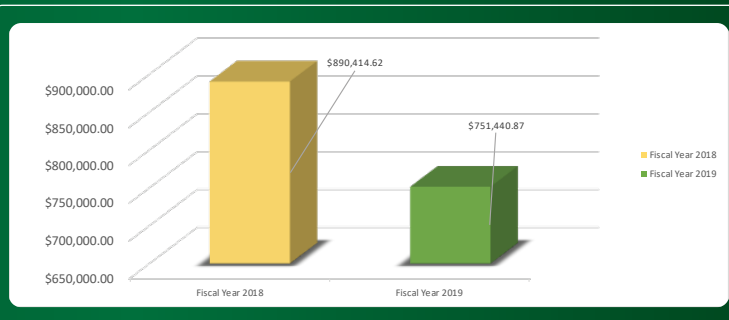

ANNUAL GIFT COMPARISON FY2018 and FY 2019

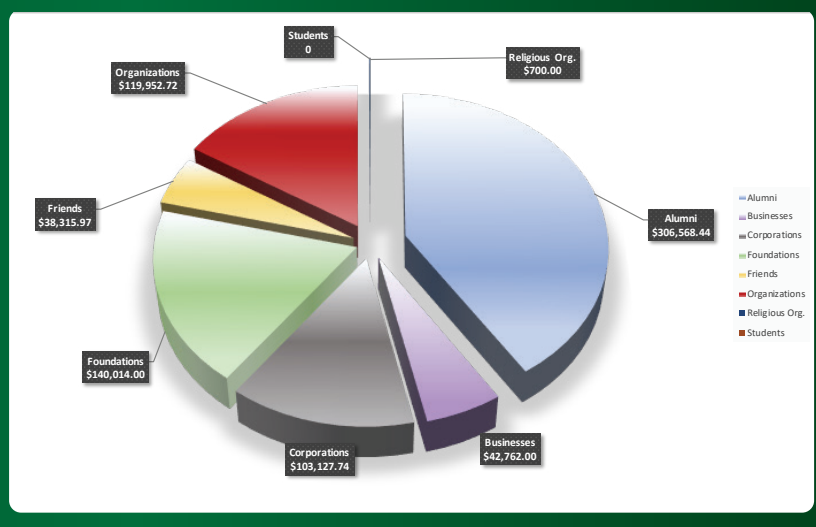

TOTAL GIFT AMOUNTS BY CATEGORY July 1, 2018 Thru June 30, 2019

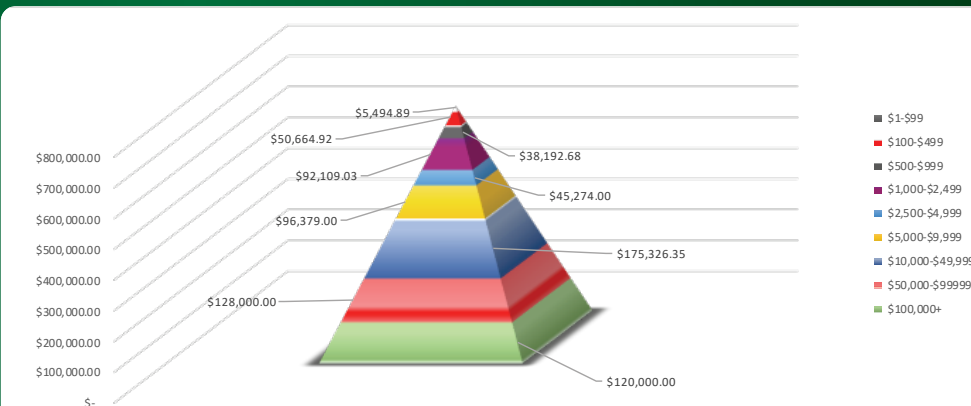

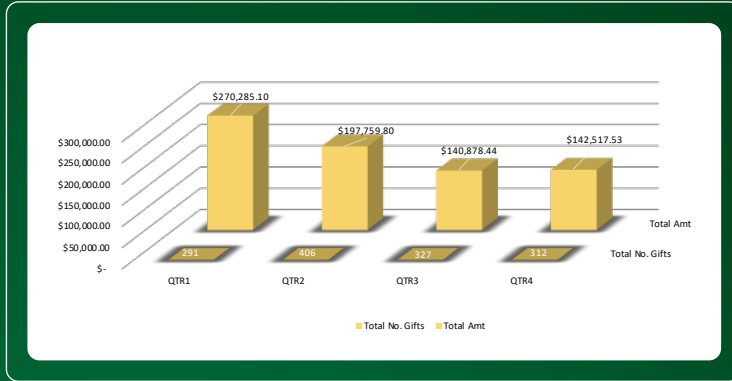

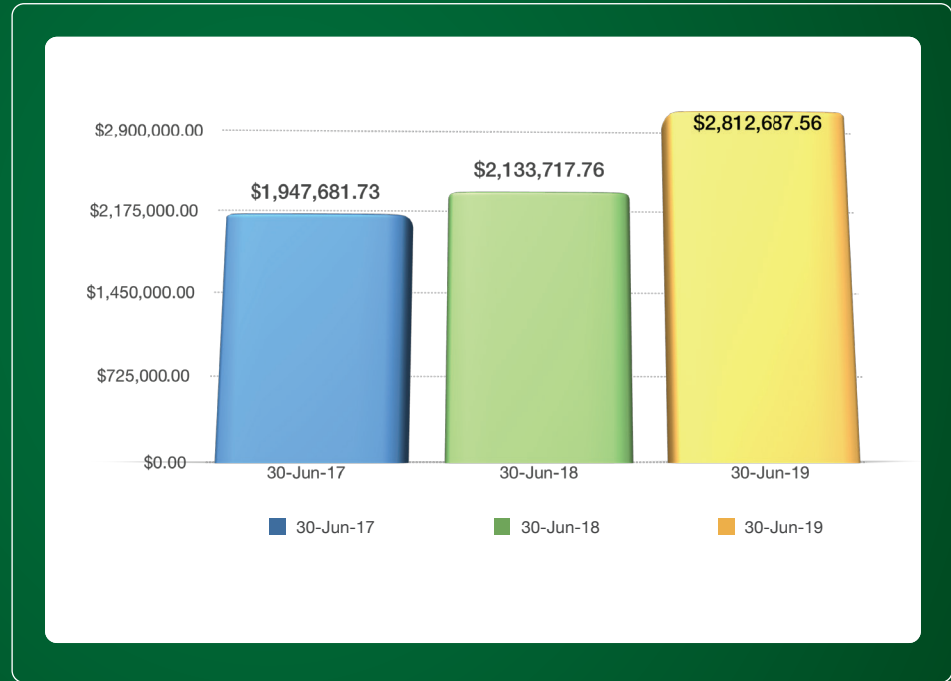
