Candidates enroll in two courses during the program where they specifically, learn how integrate technology as both a teaching and data analysis tool. The candidates are required in these courses to develop assessment instruments, administer the instruments to the students, score, and analyze the resulting data. Then they are required to instruct the students for four to six weeks. After the four to six weeks, the candidates re-administer the assessment instrument, score, and analyze the resulting data. Additionally, candidates use descriptive statistics to describe the student learning outcome.

During the MAT program, candidates are required to conduct simulations of various disabilities, conduct at least three interviews with SPED teachers and/or SPED Directors, Analyze videos for writing IEPs and practice writing IEPs, conduct case studies using IRIS Vanderbilt to apply SPED laws, and recognize the role of parents, general education classroom teachers, counselors, administrators, and other support personnel in providing services to exceptional children.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.
