# How to Apply for Housing

## First-Time Residential Students (Freshmen and Transfers only)

Requirement

Students must be admitted to <u>Mississippi Valley State University</u> before completing the residence hall Housing Application/Contract.

#### **Getting Started**

### Step-by-Step

- 1. Select the appropriate Housing Application/Contract from the links listed on the "Residential Life Forms and Information" webpage.
- 2. Thoroughly read, complete, and submit the Housing Application/Contract either by mail or by fax. (Housing Application/Contract <u>cannot</u> be submitted online or e-mailed.) If you are under 18 years of age, please have your parent or guardian sign.
- 3. A \$75.00 (non-refundable) application fee is required to submit the application; Payment can be received by credit card, money order and/or cashier's check.
  - a. **Credit Card** call the University's cashier's office at 662.254.3313. Once payment has been accepted, a receipt number will be given to confirm payment.

- ➤ The Office of Residential Life cannot process your application before receiving your \$75.00 (non-refundable) application fee. This fee cannot be waived nor added to the students account.
- If you would like to request a specific roommate, it is recommended that both parties complete and submit the Housing Application/Contract along with the \$ 75.00 application fee (per person) at the same time to the Office of Residential Life/Student Housing. **PLEASE NOTE:** the Office of Residential Life does not guarantee a particular room, roommate, or hall. All room assignments are subject to change with written notice.
- Deadline for submitting the Housing Application/Contract for 2015-2016 will be Wednesday, July 1, 2015.

- > Deadline for cancelling Housing Contract without a cancellation fee is **Tuesday**, **June 30**, **2015**.

## **Returning Residential Students**

Requirement

Students must be registered (Complete FAFSA) at <u>Mississippi Valley State University</u> for the upcoming academic school year before completing the residence hall Housing Application/Contract.

## **Obtain Housing/Room Assignment**

#### Step-by-Step

- Select the appropriate Housing Application/Contract from the links listed on the "Residential Life Forms and Information" webpage. Or by visiting the Office of Residential Life/Student Housing located in the Student Union Annex to receive a Housing Application/Contract.
   (Housing Application/Contract cannot be submitted online or e-mailed.)
- 2. Thoroughly read, complete, and submit the Housing Application/Contract to the Office of Residential Life **ONLY**.
- 3. Selecting your room and/or roommate
  - a. If selecting a particular room in a particular residence hall, it is a "first come-first serve" process.
  - b. If you would like to request a specific roommate, it is recommended that both parties complete and submit the Housing Application/Contract at the same time to the Office of Residential Life/Student Housing. REMEMBER: The Office of Residential Life does not guarantee a particular room, roommate, or residence hall. ALL room assignments are subject to change with written notice.

**PLEASE NOTE:** The Office of Residential Life cannot process your application if you <u>are not</u> a registered student for the upcoming academic school year.
