This letter is to official notification that you have been placed on academic suspension, which results from your Spring 2020 semester academic performance. This suspension is also a result of your being on academic probation for two consecutive semesters and failure to attain the required minimum cumulative grade point average. Nonetheless, your records indicate that **you have made academic progress during this past semester**. Thus, to encourage your continued progress, an appeal may be submitted by completing and returning the enclosed document.

The following steps outline the appeals process:

- The attached document requesting an appeal is submitted no later than July 6, 2020.
- The appeals document is received by the Academic Appeals Committee.
- A decision will be rendered to you by telephone and/or written notification informing you of the committee's decision.

If your appeal is successful, you will receive instructions outlining your participation in student development activities to assist you in being successful in your classes. If you elect not to appeal your suspension, you will be eligible to apply for readmission to the University Fall 2021. Your request for readmission must be received at least seven days prior to the beginning of the semester. Please contact the Office of Academic Affairs at 662.254.3800, if assistance is needed.
