COURSE DESCRIPTION:

Environmental Health seminar will focus on reading, reporting, and discussion of selected current scientific literature pertaining to environmental and health-promotion of human health. This course will also focus on internship experience, academic and career advisement and professional advancement.

COURSE OBJECTIVES:

1. Keep students abreast of current environmental and health literature-developments and knowledge that promote human health through understanding and proper management of the environment.

2. Develop skill in reading with comprehension, summarizing the read information in simple outline and narrative forms, and making oral and written reports of the pertinent literature and developments.

3. Improve writing skills, and interviewing techniques.

4. Increase vocabulary of environmental health terms and become familiar with various environmental agencies and function.

5. Enhance understanding of the natural principles relative to everyday personal and public health, and societal issues and concerns.

CRITERIA FOR CRITIQUEING JOURNAL ARTICLES

Analysis for Journal Articles (Critique)

- Identify your article by title, author and source
- Review the content of the article, summarize its main points. What is the problem/issue/argument that this article is reflecting.
- Identify how this article relates to the field of public health, what area of public health it deals with and tell why the article may be of importance in the field. Relate the article to the chapters covered in class.
- Articulate the meaning and thought you have derived from the article. Does it have any special importance to you or to a particular segment of society? Why? You must show that you have thought about the article. Do you questions the results or conclusions that the article draws? Do you feel the article or the research it reports on was lacking in some way?
- Please follow instructions and watch grammar, spelling, etc. Please proofread before submission.
- Remember, late articles will not be accepted. Critiques are due at the beginning of class on the schedule date.
- All articles should be font 12 point Time Roman

Note: In reviewing journal articles, it will demonstrate your ability to understand an article; to enhance your ability to critique an argument; to improve your ability to communicate your points in an academic fashion and to gain knowledge in the area of public health and administration.
