INDUSTRIAL/ORGANIZATIONAL PSYCHOLOGY

COURSE DESCRIPTION

This course teaches students about the role of supervision functions in industry with emphasis on principles and practices of human behavior and human relations within the industrial environment. It will examine theories of communication, leadership, motivation, group dynamics, change, conflict management, organizational culture, and culture differences to create effective organizational functioning.

D. COURSE LEARNING OUTCOMES (CLOs)

Upon successful completion of this course, the student will be able to:

- a. Describe what is business psychology
- b. Present an overview of how people learn both simple skills and more complex activities
- c. Explain how values influence job behavior
- d. Describe how to make effective use on mental ability
- e. Identify major personality factors and traits and describe how that relate to job performance
- f. Describe the nature of self-esteem and how it affects the behavior of people
- g. Point key factors that influence the quality of problems solving and decision making
- h. Explain several approaches organizations take to enhance creativity
- i. Describe the key elements of Maslow's Hierarchy of need and the expectancy theory of motivation
- j. Point out how behavior modifications is applied to motivate employees
- k. Develop a strategy for enhancing your own motivation
- l. Analyze problems related to behavior and mental processes.
- m. Evaluate psychological phenomena from a biblical perspective.
- n. Apply psychological theory to everyday life.

E. COURSE REQUIREMENTS AND ASSIGNMENTS

After reading the Course Syllabus and Student Expectations, the student will complete the related checklist found in Module/Week 1.
- c.** Discussion Board Forums (6)
Discussion boards are collaborative learning experiences. Therefore, the student is required to provide a thread in response to the provided prompt for each forum. Each thread must be at least 250 words, be in current APA format, and cite the course textbook. In addition to the thread, the student is required to reply to two (2) other classmates' threads. Each reply must be at least 125 words.
- d.** Online Success Assignment
The student will reflect upon his or her individual situation and obligations in order to create a plan for success in this course. Upon reading articles related to the topic of student success in online courses, the student will write a brief paper in current APA format. The paper must be 3–4 pages, not including the title and reference pages.
- e.** Personality Assignment
The student will complete a personality test and research his or her results. The student will consider the results and respond to provided prompts to write a brief paper in current APA format. The paper must be 3–4 pages, not including the title and reference pages.
- f.** Chapter Quizzes (10)
The student will complete 10 quizzes. Each quiz will be open-book/open-notes, contain 20 multiple-choice and true/false questions, and have a 45-minute time limit. The student will have the ability to take each quiz twice with the highest score recorded in the grade book.

F. INCOMPLETES

An incomplete is not given automatically or lightly. Anyone requesting an incomplete will have to do so in writing and will be considered only if:

- a.** At least 75% of the course activity has been completed;
- b.** The student is at least pulling a minimum of C grade;
- c.** No points will be given for missing discussion board assignments and quizzes.
