I. Call to order: Dr. Newsome

### **II. Continuing Business:**

- A. Discussion of Faculty Senate Standing Committees: Dr. Newsome discussed the process of electing committee members. All Faculty Senate Standing Committee members must be voted in before serving on the committee.
- B. Dr. Boyd motioned to move and vote all volunteers for the Faculty Senate Standing Committee: Dr. Newsome seconded the motion.

### III. New Business:

- A. Introduction of Tenure Proposals: Ms. Mantra Henderson (Library Director)
  - a. Ms. Henderson discussed changing the tenure and promotion process for librarians. Ms. Henderson also discussed the history of ACRL (Association of College & Research Libraries) and the standards behind this association.
  - b. Ms. Henderson also discussed what a terminal professional degree is for academic librarians. A terminal degree for professional librarians according to ALA (American Library Association) standards is a MLS or MLIS degree.

- Ms. Henderson also discussed IHL standards on tenure & promotion for Librarians.
  - i. Librarians with full faculty status & tenure
  - ii. Librarians with faculty or academic status but no tenure
  - iii. Librarians without faculty or academic status
  - iv. Librarians without faculty or academic status but with tenure status.
- B. Librarian Expectations: Ms. Henderson elaborated on how tenure & promotion will allow Librarians to pursue grants as well as work on other proposals. It would also allow us to better recruit librarians.
- C. Criteria Questions and Responses for Tenure Promotion
  - a. What is the difference between instructors and librarians?
    - i. (Librarians MLIS degree is considered a terminal degree. Librarians hired on tenure-track would begin as Assistant Professors).
  - b. What is the process and steps for librarians to get tenure?
    - i. (The tenure proposal will be given out at a later date to Dr. Newsome).
  - c. How many librarians might these changes affect?
    - i. If approved, Ms. Henderson is, at present, the only library faculty who might immediately qualify for tenure and promotion
  - d. What is the timeframe of the tenure?
    - i. (Next Academic School Term Year)

### IV. Task Force Sustainability:

- A. A Task Force Sustainability Committee has been established to replenish funds back to MVSU. A list of recommendations from the committee is below.
  - a. Department Chairs Reduction
  - b. Utilizing Graduate Assistants
  - c. Hiring more Adjunct Faculty
