Fourteen institutions of higher learning that comprise the Mississippi Education Preparation Providers (EPP) requested that the Statewide Longitudinal Data System (SLDS) provide information required for national accreditation through CAEP. These 14 institutions are Alcorn State University, Belhaven University, Blue Mountain Christian University, Delta State University, Jackson State University, Mississippi College, Mississippi State University, Mississippi University for Women, Mississippi Valley State University, Tougaloo College Rust College, The University of Mississippi, The University of Southern Mississippi, and William Carey University.

Each of the 14 institutions provided the SLDS Clearinghouse with supplemental data containing information on teacher education program completers, including certification track (traditional vs. alternate route), licensure exam results, Teacher Intern Assessment Instrument (TIAI) and Disposition scores, as well as admission information. The data were used in conjunction with de-identified data already in the SLDS Clearinghouse to produce reports to assist with CAEP annual reporting measures.

A cohort design was used where individuals graduating from each of the EPPs in a given academic year were followed over time to identify their subsequent performance outcomes. Reports containing the results were produced for each participating EPP as well as a statewide report which is contained in this Mississippi Impact Report Card. The statewide Educator Preparation Provider Collaborative Committee (EPPCC) designated a subcommittee to develop the format and methodology of the Mississippi Impact Report Card led by Dr. Mitzy Johnson and Mrs. Jenny Hartness (Mississippi State University), Dr. Ann Monroe and Dr. Sara Platt (University of Mississippi), and Dr. Yanbing Tang and Mr. Leslie Charlton (National Strategic Planning and Analysis Research Center (NSPARC)).

### Interpretation of the Data:

This report provides information on the learning outcomes of Mississippi public school students taught by Mississippi Valley State University Education Department program completers. Statistics on these students' standardized assessment performance are reported. To provide context and comparison, a corresponding set of data for all Mississippi public school students statewide is reported as well as data from Mississippi public school students taught by the same year cohort completers from other EPPs in the state.

**“Statewide All Teachers”** includes the test data for every student of every teacher in MS public schools.

**“Statewide EPP Total”** includes the test data for students taught by a teacher graduating from the indicated cohort from the 14 EPPs participating in the report.

**“Institution EPP Total”** includes the test data for students taught by a MVSU completer from the indicated cohort.

Mississippi Valley State University's Traditional Route program saw several promising performance outcomes. Notably:

- One Grade 6 Math teacher from the 2021–2022 completer cohort (2nd-year teacher) achieved 85.71% of their students at Proficient or Advanced, outperforming both the statewide average (46.15%) and the statewide EPP average (52.35%).
- The same cohort included a Grade 6 English teacher whose students scored 54.76% at Proficient or Advanced, exceeding both the Statewide (40.70%) and Statewide EPP (47.01%) rates.

Alternate Route MAT completers from MVSU also contributed to significant student gains:

- A Grade 7 Math from the 2019-2020 completer cohort 3<sup>rd</sup> year teacher taught students with a Proficient/Advanced rate of 58.14%, surpassing the Statewide Teacher average (56.84%).
- A Grade 8 Science teacher from the same cohort taught students with a Proficient/Advanced rate of 56.52%, surpassing both the Statewide Teacher (46.86%) and EPP (49.72%) averages.

While overall averages for MVSU completers remain below statewide benchmarks in many categories, notable individual achievements stand out. These successes affirm MVSU's commitment to preparing educators who are capable of fostering student learning in meaningful ways. The inclusion of these data not only helps MVSU track areas of growth but also celebrates the impactful work of its completers who are already making a difference in Mississippi classrooms.
