Faculty have both laptop and desktop computers in their offices to develop and present their instructions, and to quantify the results of the students learning outcomes. The faculty receive an on-going faculty development while the candidates receive training on how to integrate technology in their instructions using Permethian and Smart-boards. The candidates are required to make all their presentations using LCD projections and tri-folds formats.
